# For the Fall 2022 Obedience & Rally Trial sponsored by the BURLINGTON OBEDIENCE TRAINING CLUB

The following pages show samples of BOTC's Obedience Trial and Rally Trial entry forms for the Fall 2022 Obedience and Rally Trials. These sample pages are annotated with some helpful hints on filling out the formS.

If this is your first Obedience or Rally Trial, we're happy you chosen BOTC! Here are a couple more items that you may find helpful:

- 1. Please write clearly and legibly. We cannot get your dog entered properly if we can't read the form.
- 2. <u>Forms</u> The Premium includes one form for entering the Obedience classes and a second form for entering the Rally classes. If you are entering <u>both</u> Obedience and Rally classes, please make sure there are two entry forms in the envelope you mail to us.
- 3. While there are 4 trials over the course of the two day weekend (2 Obedience, 2 Rally), you can send one check to cover your entry fees for whatever number of classes and trials classes you enter.
- 4. <u>Catalog</u> If you'd like to have a printed catalog, please check that box on <u>one</u> of you entry forms and include an extra \$3.00 in your entry fee calculation. We'll print you a single Catalog covering all the classes for the Obedience and Rally trials for the whole weekend and it will be ready for you at the Trial Secretary's table when you get to the trial.
- 5. <u>Confirmations</u> We will send you a confirmation email shortly after we received your entry ..... but please give us a week or so after you mail your entry before starting to worry (and don't worry). It's apparently all uphill to our mailbox and the US Postal Service trucks take a while to navigate their way to us....and we also work real jobs so we process entries in batches every couple of days.
- 6. <u>Jump Height</u> If you are not sure of your dog's jump height, don't worry. Determining your dog's proper jump height is a little more complicated in Obedience and Rally than in AKC Agility but it's not hard. If you are not sure what height to use, send us an email and we'll guide you thru it.
  - We'll also likely have a AKC VMO (Volunteer Measuring Official) at the trials. If you have a dog at least 15 month old with whom you might like to try agility, take the opportunity to get an official measurement. That will tell you what height your dog will jump in Agility Competitions and mean there's one less thing to do at your first agility trial. Please note: Your dog doesn't need to be entered in the Obedience or rally trials to be measured for an agility height card <u>and</u> measurements are free!
- 7. Facility If you've not been to the Trial site before, we think you'll like it. BOTC holds our agility trials at this same facility and both our Agility and Obedience/Rally competitors have been very pleased with events at this site. There's plenty of indoor crating space, paved parking and lots of grass around the building for walking your dog. The ring surface is artificial turf.
