Learn how to read your dog and help them make correct decisions while working in order to enhance their tracking experience. Workshop will consist of component track for you to work with your dog. All participants will follow along from one track to the next to learn from each other's experiences. Ilene and Lynda will assist, instruct and critique each dog and handler team.

The workshop is structured to provide handlers with personal instruction tailored specifically to their dog.
